0 Executive Summary

This is a simple and straightforward *PLM Handbook for SMEs*. It explains the subject from a small- or medium-sized business perspective, dispels some of the myths and errors that exist, and sets out a methodology for mastering the subject.

SMEs looking at PLM for the first time will find no shortage of technical advice - the Internet has lots of it, and as soon as you approach a vendor to discuss buying some PLM software, you will get a lot more.

Almost all of this will be generic or proprietary. All of it will be advice that is aimed at large companies.

For an SME, the CEO as well as the potential hands-on PLM Project Manager will need to make sense of this, and understand how it all applies to their own specific business. That is the purpose of this *Handbook*.

It is designed to be read by the CEO (or whichever VP is assigned to head up PLM); as well as the PLM Project Manager (the technical person tasked with "doing PLM"). It acts as an interface that lets an SME engage accurately with the wider world of PLM.

Eventually you will want to make the investment - to spend money on PLM improvements and software, that you want to be useful and effective. By reading the *Handbook* first, following the logic and doing the preparation, you will find that all of the generic and proprietary information falls into place.

The *Handbook* is also useful for SMEs that have started on PLM, and want to cross-check to see if they are going in the right direction.

The *Handbook* has a clear and logical structure that begins with Preparation to understand the overall PLM context. It then describes how SMEs can relate to PLM so that they can start their journey from the right place.

There is a detailed list of Instructions that guide the PLM Project Manager through the work that will be required in order to define and complete the investigation; and guidelines on how to apply PLM, and on some advanced subjects to consider.

This is not an encyclopaedia - a full written explanation of PLM would run to many hundreds of pages, and would be unusable for an SME. SMEs need concise, accurate information that they can process quickly and act on easily. That is what the *PLM Handbook for SMEs* provides.

However, the *Handbook* is an instruction book, and not a just a casual read, so the Sections are numbered for easier navigation and use.
